SP approves Supplemental Budget No. 1 in 7 days

Within seven (7) working days, the Sangguniang Panlalawigan headed by Vice Governor De Carlo “Oyo” L. Uy approved the Supplemental Budget No. 1 through the Appropriation Ordinance No. 2023-001 during the Second Special Session on June 2, 2023.

A total budget of more than 600 million pesos was approved by the nine (9) present Board Members—as presided by Vice Governor Oyo Uy, appropriated for the General Fund Proper (PhP 543,642,669.89) and Economic Enterprise (PhP 61,037,045.65) of the Province of Davao del Norte.

The letter from the Honorable Governor Edwin “Kuya Gob” I. Jubahib, containing the proposed budget, was received by the Vice Governor’s Office on May 24, 2023. It was then endorsed to the Office of the Secretary to the Sanggunian

(OSS) on May 25, 2023. That same day, the letter was included for First Reading in the Calendar of Business during the 22nd Regular Session on May 29, 2023. Thereafter, the letter was referred to the Committee on Finance, Budget, and Appropriations.

On May 31, 2023, a Committee Hearing was conducted. Through its Committee Report No. 120, the Committee on Finance, Budget, and Appropriations recommended passing the measure for Second Reading.

Finally, on June 2, 2023, the 9th Sangguniang Panlalawigan called for a Second Special Session. Considering the urgent need for funds, the SP approved the said budget on the same day, under suspended rules for quick implementation.

Under the General Fund Proper

are various projects or services which include the General Public Services. Under this is the Socio-Cultural project with a budget of Php 20,432,000.00. This includes the budget for the 56th Araw ng Davao del Norte celebration last July 1, 2023.

In a Facebook post, Vice Governor Oyo Uy ensured that the 9th Sangguniang Panlalawigan will continue to strengthen its cooperation with the Executive Department, in order to allocate funds for different programs, projects and activities that will benefit the people of Davao del Norte.

BM Lu, with a drive to make a difference in serving the marginalized and health sector

"That is why it's important to try to make a difference no matter how small or negligible it is," Dr. Denise Marianne A. Lu emphasized in one of our afternoon conversations. Her drive to be able to make a change, how small and negligible, in the realm of politics, governance and the local government is like a ripple we create that bear waves. All she has is an open heart to reach out even further to all Dabaonons and provide services that people need. "Hopefully, makahatag ko sa serbisyo nga gikinahanglan sa marginalized and health sector."

Her heart to help the people is first and foremost among the reasons she ran for public office during the 2022 Elections. One may think that she's a budding politician in her advanced years, but public service is no longer new to her. She has been a practicing medical doctor who has served the community for more than 40 years and would like to continue extending a helping hand in another capacity as a public servant, widening her reach to the community. Entering politics was never in her wildest dreams but, lo and behold, fate and circumstances brought upon a chance of a lifetime.

Denise Marianne Racaza Alix-Lu is the wife of the late Dr. Daniel Aboyme Lu, who took a seat as a Board Member of the 2nd District of Davao del Norte in 2019 but wasn't able to complete his term of office due to his untimely death. The untimely demise of her husband in June of 2020 brought grief and despair but it also opened a new window of opportunity to see the light, to step up to the frontlines and go beyond one's perceived life purpose. She has kept herself out of sight from the discerning eyes of the public throughout her husband's longstanding political stint but, nonetheless, she had been closely working with him, silently observing and growing with him in serving the Dabaonons and looking after the general welfare of the constituents.

Dr. Denise Lu took on the challenge to continue the legacy her husband left behind. She took oath as Board Member of the 2nd District of the Sangguniang Panlalawigan of Davao del Norte upon the issuance of her appointment by, no other than, His Excellency, President Rodrigo R. Duterte on January 19, 2021. She was immediately directed to enter upon the performance of her duties and serve the remaining term of her husband.

For a year, she visited almost all barangays in District II and talked about ways to maintain good health. She arranged dialogue with Barangay Health Workers and delivered medical implements necessary in Barangay Health Centers such as sphygmomanometer and glucometer, visited and checked upon the situation of Davao del Norte Hospitals –Kapalong, Carmen, and Samal and gave support, and worked closely with the Provincial Health Office and the Local Health Board to promote proactive legislation.


Upon the end of her first term, Hon. Lu realized that a year is not enough to do all the things she envisioned for Davao del Norte and her constituents. Hence, she sought for re-election knowing that the people of Davao del Norte believed she can mobilize change. She won the election and continues her office to represent and to compose the 9th Council of the Sangguniang Panlalawigan of Davao del Norte.

As chairperson of the Committee on Health and Social Services and the Committee on Government Enterprise, driven by her passion to empower the marginalized and look after the health sector of the province, she acted upon ordinances, approved resolutions and appropriated funds necessary for the general welfare of the province and ensure the efficient and effective delivery of basic services.

When people ask BM Lu, MD to describe herself, she doesn't hesitate to say that first and foremost, she is Adrian, Tsikee, LeeBoy and Chico's mom. But before she was a mother –or a wife, doctor or public servant –she was Antero and Bernabella Cecilia's

second child. The Alixes lived in downtown Cebu and the young Denise grew up together with her two siblings, her parents, grandma, her uncle and cousins. Antero was an Engineer- Architect and a hardworking head of the household while Bernabella, a pharmacist, left her career in the corporate world to take care of the family.

Dr. Lu finished her primary and secondary education at Sacred Heart School for Girls. In college, she first studied Biology at University of San Carlos but later on decided to change her course to Medical Technology at Velez College, both in Cebu City. She, then, met Daniel A. Lu, a Dabaonon, who would catch her elusive heart and become her first boyfriend and ultimately the love of her life. After a few years of hurdling together the hardships of entering and overcoming Medical School, they became full-fledged doctors in 1982. They decided to build their family in Mindanao and Dr. Denise decided to have her residency training at Davao Doctor's Hospital and later moved to Ramon Lu Medical Clinic and Hospital for private practice where her husband is the Medical Director. At the time when Dr. Daniel's political career flourished, Dra. Denise sought a permanent job at Lapanday Foods Corporation as a company physician while tending to their family.

Being a doctor and a public servant are both fulfilling professions the couple endeavored in different timelines but both shared the same aspiration, that is, to serve the people and to create change for the betterment of Davao del Norte and to live by example as Christ taught. Dr. Lu sought to live a good Christian life enabling her to serve for the purpose. As Mother Teresa posits, "I alone can't change the world but I can cast a stone across the waters to create many ripples." Just as ripples spread out, Dr. Lu submits that our actions can have far-reaching effects.

Panaboan whiz wins Multiple Gold Awards in International Math and Science Olympics

The Philippine flag took centrestage by the prodigious victory of Mr. Ralph Moses Lacno Padilla, a resident of Barangay New Visayas, Panabo City who bagged multiple trophies and medals in the Siam International Math and Science Olympics (SIMSO) last October 30, 2022. SIMSO, a Thailand-based academics competition, traditionally conducted in said country's capital city of Bangkok was conducted via virtual platform that year in consideration of the COVID-19 pandemic situation.

He was awarded the prestigious SIMSOLVER CUP – a Special Award for winning gold awards in both Math and Science categories in the aforesaid competition. The Panaboan whiz bested participants from all over the world including country representatives from Singapore, Thailand, Vietnam, India, Malaysia, Indonesia, Cambodia and Australia among others.

Mr. Padilla, an undisputed genius, is no greenhorn to such honours and achievements as he had also received awards from various City,

Provincial, National and International Math and Science Competitions. A product of DavNor's very own Davao del Norte State College (DNSC), he was recognized by the Department of Science and Technology (DOST) for his outstanding triumphs and was bestowed the DOST Medal for Youth Excellence in Science Award.

In view of his triumphs, Hon. Denise Marianne A. Lu, MD, Sangguniang Panlalawigan (SP) Member from the 2nd Legislative District, authored Resolution No. 208, Series of 2023 which commended the exemplary accomplishments of Mr. Padilla. An awarding ceremony was also held last June 19, 2023 at the SP Session Hall, Capitol, Mankilam, Tagum City in honor of the Dabaonon genius, wherein a framed copy of the aforementioned legislation was handed to him by the provincial legislators. Aforesaid ceremony was also attended by Ms. Fe L. Padilla, the awardee's mother and Ms. Prencess Jane D. Galaura, his significant confidante. 🏆
