EXECUTIVE ORDER No. 24

AN ORDER RECONSTITUTING THE LOCAL SCHOOL BOARD (LSB)
OF DAVAO DEL NORTE PROVINCE

WHEREAS, Section 98 (a) of RA 7160 otherwise known as the Local Government Code of 1991 provides for the creation of the Local School Board in every Local Government Unit (LGU) with specific guidelines

WHEREAS, the Local School Board of Davao del Norte was created pursuant to the above-mentioned provision;

WHEREAS, there is a need to reconstitute the said Board due to the separation from service and assignment/transfer of some members to other offices/agencies;

WHEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte, by virtue of the power vested in me by law, do hereby order the reconstitution of the Local School Board of Davao del Norte with the following provision;

Section 1. Composition. The Local School Board of Davao del Norte as reconstituted, shall be composed of the following:

Section 2. Duties and Functions. The Local School Board of Davao del Norte shall:

- 2.1. Determine, in accordance with the criteria set by the Department of Education, the supplemental budgetary needs for the operation and maintenance of public schools within Davao del Norte and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the special education fund and such other sources of revenue as the Local Government Code (RA 7160) and other laws or ordinances may provide;

- 2.2. Authorize the Provincial Treasurer to disburse funds from the special education fund pursuant to the budget prepared in accordance with applicable existing rules and regulations;
- 2.3. Serve as Advisory Committee to the Sangguniang Panlalawigan on educational matters such as, but not limited to, the necessity for and the uses of local appropriations for educational purpose; and
- 2.4. Recommend changes in the names of public schools within the territorial jurisdiction of Davao del Norte for enactment by the Sangguniang Panlalawigan.

Section 3. The Secretariat. The Provincial Budget Office shall serve as the Secretariat to this Board.

Section 4. Operation. All matters concerning the operation of the subject board shall be in accordance to the provisions of the implementing rules and regulations of RA 7160, specifically Rule XXIII, Article 184, thereof.

Section 5. Effectivity. This order shall take effect immediately thereby revoking Provincial Executive Order No. 006, dated 05 July 2007.
