**AN ORDER AMENDING EXECUTIVE ORDER NO. 34, SERIES OF 2016 ENTITLED, "AN EXECUTIVE ORDER CREATING THE COMPOSITION OF THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRRMC) OF DAVAO DEL NORTE, ITS TECHNICAL MANAGEMENT COMMITTEE AND TECHNICAL WORKING GROUP"**

WHEREAS, by virtue of Executive Order No. 34, series of 2016, the composition of the PDRRMC of Davao del Norte, its Technical Management Committee and Technical Working Group was created in accordance with Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction Management Act of 2010;

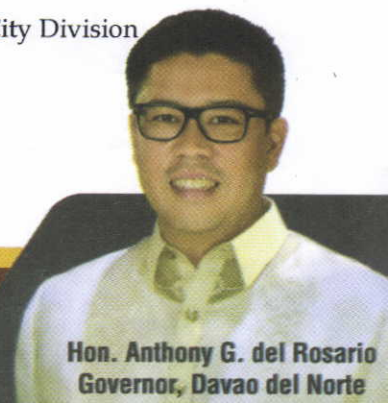
WHEREAS, several months after the Executive Order took effect, there was the arising need to amend the Technical Working Group of the PDRRMC of Davao del Norte;

WHEREAS, the amendment of the Technical Working Group aims for a more effective coordination between agencies involved in the planning, implementation, monitoring, and evaluation of the mandates of a Provincial Disaster Risk Reduction and Management Council;

NOW THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte, by virtue of the power vested in me by law, do hereby order the following:


Section 2. Funding provision as stipulated in Section 7 of Executive Order No. 34, series of 2016 is hereby amended to read as follows:

*In order to sustain the activities of the Technical Working Group of PDRRMC, an appropriate budget shall be included consistent with Section 21 of Republic Act 10121.*

Section 3. Separability Clause. All other provisions stipulated in Executive Order No. 34, Series of 2016 not affected by this amendment shall remain valid and in force.

Section 4. Effectivity. This order shall take effect immediately upon signing hereof and shall remain in force unless revoked or amended accordingly.
