### RESOLUTION NO. 036

**CONFIRMING RESOLUTION NO. 200, SERIES OF 2016 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, THIS PROVINCE, "APPROVING AND ADOPTING THE PROGRAMS AND PROJECTS PRIORITIZED UNDER THE CY 2017 MODIFIED ANNUAL GENDER AND DEVELOPMENT (GAD) PLAN OF THE MUNICIPALITY OF STO. TOMAS, DAVAO DEL NORTE IN THE AMOUNT OF SIXTEEN MILLION FOUR HUNDRED ELEVEN THOUSAND FOUR HUNDRED FIFTY-SEVEN PESOS AND 38/100 (P16,411,457.38) UNDER 5% GAD OF THE CY 2017 ANNUAL GENERAL FUND BUDGET OF STO. TOMAS"**

Tomas, this Province, "Approving and adopting the programs and projects prioritized under the CY 2017 modified Annual Gender and Development (GAD) Plan of the Municipality of Sto. Tomas, Davao del Norte in the amount of Sixteen Million Four Hundred Eleven Thousand Four Hundred Fifty-Seven Pesos and 38/100 (P16,411,457.38) under 5% GAD of the CY 2017 Annual General Fund Budget of Sto. Tomas";
