RESOLUTION NO. 044

CONFIRMING CITY ORDINANCE NO. 772, S-2016 OF THE SANGGUNIANG PANLUNGSOD OF TAGUM, THIS PROVINCE, "AN ORDINANCE REQUIRING ALL GOVERNMENT OFFICES AND COMMERCIAL ESTABLISHMENTS IN THE CITY OF TAGUM TO PROVIDE EXPRESS LANES AND /OR PRIORITY FOR SENIOR CITIZENS, PERSONS WITH DISABILITIES AND PREGNANT WOMEN AT THE POINT OF SALE AND TRANSACTION AREAS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF"

WHEREAS, a letter dated December 22, 2016 of Mr. Rey A. Buhion, Secretary to the Sanggunian, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, transmitted to this August Body, City Ordinance No. 772, S-2016, of the Sangguniang Panlungsod of Tagum, this Province, was presented for appropriate action;

WHEREAS, the said measure was jointly referred to the Committee on Women, Children and Family Relations and the Committee on Health and Social Services for review and recommendation;


WHEREAS, the Committees thoroughly discussed and deliberated on the merits of said request and per Joint Committee Report No.01, dated January 11, 2017, finally recommended to confirm the same for being in order and within the bounds of law.

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled, to confirm, as it is hereby confirmed, City Ordinance No. 772, S-2016, of the Sangguniang Panlungsod of Tagum, this Province, "An ordinance requiring all government offices and commercial establishments in the City of Tagum to provide Express Lanes and /or priority for Senior Citizens, Persons with Disabilities and Pregnant Women at the point of sale and transaction areas and providing penalties for violations thereof";

RESOLVED, FURTHER, that copy of the resolution be furnished the Sangguniang Panlungsod of Tagum this Province, through Mr. Rey A. Buhion, Secretary to the Sanggunian for their information and record.
