## **RESOLUTION NO. 091**

**AUTHORIZING HONORABLE GOVERNOR ANTONIO RAFAEL G. DEL ROSARIO ON BEHALF OF THE PROVINCE OF DAVAO DEL NORTE TO ENTER, NEGOTIATE AND SIGN ALL CONTRACTS/AGREEMENTS OR INSTRUMENTS WITH GOVERNMENT OR PRIVATE ENTITIES RELATIVE TO THE GRANT OF SEMINARS, TRAININGS AND SCHOLARSHIP, FREE OF CHARGE, WITHIN OR OUTSIDE THE PHILIPPINES**

**WHEREAS**, a letter dated 20 December 2016 of Mr. Samson J. Sanchez, MPA, CSEE, (Provincial Administrator), OIC-Governor, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, requesting the August Body for the passage of a resolution authorizing the Honorable Governor to enter, negotiate and sign all contracts/agreements or instruments with government or private entities relative to the grant of seminars, trainings and scholarship, was presented for appropriate action;

**WHEREAS**, said measure was referred to the Committee on Laws, Resolutions, Ordinances and Justice and the Committee on Education and Culture for study and recommendation;

**WHEREAS,** the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report No. 01 dated January 18, 2017, finally recommended to confirm the same for being in order and within the bounds of law.

**WHEREFORE, BE IT RESOLVED,** by the Sangguniang Panlalawigan in Session Assembled, to authorize, as it is hereby authorized, Honorable Governor Antonio Rafael G. del Rosario on behalf of the Province of Davao del Norte to enter, negotiate and sign all contracts/agreements or instruments with government or private entities relative to the grant of seminars, trainings and scholarship, free of charge, within or outside the Philippines;

**RESOLVED, FURTHER,** that copy of this resolution be forwarded to Honorable Antonio Rafael G. Del Rosario, Governor, this Province, for appropriate action; let copies of the same be furnished Mr. Samson J. Sanchez, MPA, CSEE, Provincial Administrator, Ms. Monica L. Salido, MM, Provincial Human Resource Management Officer and Atty. Jennifer B. Namoc-Yasol, Provincial Legal Officer, all of this Province for their information and record.
