## RESOLUTION NO. 092

**AUTHORIZING HONORABLE ANTONIO RAFAEL G. DEL ROSARIO, GOVERNOR, THIS PROVINCE TO SIGN THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE SOUTHERN PHILIPPINES MEDICAL CENTER (SPMC), CONFIRMATORY DRUG TESTING LABORATORY, JP LAUREL AVENUE, DAVAO CITY, REPRESENTED HEREIN BY ITS CHIEF DR. LEOPOLDO J. VEGA, MD, FPCS, FPATACSI, MBA-H, HEREINAFTER REFERRED TO AS THE FIRST PARTY AND THE PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, THROUGH THE DAVAO DEL NORTE DRUG TESTING LABORATORY, REPRESENTED BY THE HONORABLE GOVERNOR, HEREINAFTER REFERRED TO AS THE SECOND PARTY, RELATIVE TO SPMC'S SERVICES FOR THE CONDUCT OF CONFIRMATORY TESTS ON SPECIMENS SCREENED BY THE DAVAO DEL NORTE DRUG TESTING LABORATORY**

**WHEREAS**, a letter dated 16 December 2016 of Hon. Antonio Rafael G. del Rosario, Governor, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, endorsed to this August Body the Memorandum of Agreement to be entered into by and between the Southern Philippines Medical

Center (SPMC) Confirmatory Drug Testing Laboratory and the Provincial Government of Davao del Norte, through the Davao del Norte Drug Testing Laboratory, was presented for appropriate action;

**WHEREAS**, said measure was referred to the Committee on Laws, Resolutions, Ordinances and Justice and the Committee on Health and Social Services for study and recommendation;

**WHEREAS**, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report No. 01 dated January 18, 2017, finally recommended to confirm the same for being in order and within the bounds of law.

**WHEREFORE, BE IT RESOLVED**, by the Sangguniang Panlalawigan in Session Assembled, to authorize, as it is hereby authorized, Hon. Antonio Rafael G. del Rosario, Governor, this Province, to sign the Memorandum of Agreement entered into by and between the Southern Philippines Medical Center (SPMC) Confirmatory Drug Testing Laboratory, JP laurel Avenue, Davao City, represented hereinafter by its Chief Dr. Leopoldo J. Vega, MD, FPCS, FPATACSI, MBA-H, hereinafter referred to as the First Party and the Provincial Government of Davao del Norte through the Davao del Norte Drug Testing Laboratory, represented by the Honorable Governor, hereinafter referred to as the Second Party, relative to SPMC's services for the conduct of confirmatory tests on specimens screened by the Davao del Norte Drug Testing Laboratory;


**RESOLVED, FURTHER**, that copy of this resolution be forwarded to Honorable Antonio Rafael G. Del Rosario, Governor, this Province, for appropriate action; let copies of the same be furnished Dr. Leopoldo J. Vega, MD, FPCS, FPATACSI, MBA-H, Medical Chief, Southern Philippines Medical Center (SPMC), Davao City and Atty. Jennifer B. Namoc-Yasol, Provincial Legal Officer, Provincial Legal Office, this Province for their information and record.
