This Agreement is made and entered into this 23 day of NOV 2020 at Tagum City, Davao del Norte, Philippines, between:

PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg., Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

TAGUM CONSTRAK CORP., a registered construction firm under the Securities and Exchange Commission with Certificate No. CS201734864, dated 13-October-2017, with business address at Purok 3-A, Unit 5, Brgy. Apokon, Tagum City, Davao del Norte, duly represented by its President, **EDMUND M. SABALO**, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;


WHEREAS, the Procuring Entity through 20% DF CY 2020 (Peace and Order), intends to apply the sum of **THREE MILLION NINE HUNDRED THIRTY-FOUR THOUSAND NINE HUNDRED SEVENTY-FIVE PESOS AND NINETY-FIVE CENTAVOS (PHP 3,934,975.95)** being the Approved Budget for the Contract (ABC) for the **1 Lot Contract Package for Equipment, Labor and Materials for Various Rural Electrification: A. Rural Electrification at Ramada Compound at Prk. Sto. Niño, Brgy. Cuambogan, Tagum City, Davao del Norte; and B. Rural Electrification at Lower Camansa at Prk. 5 to 6 Lower, Brgy. WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

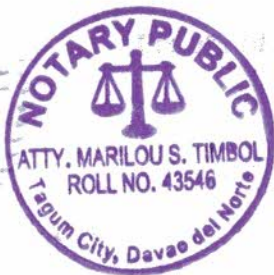
