(Community-Based Road Maintenance Contract of 11DAN079: Cebulano - Loceta (ADD 1))

KNOW ALL MEN BY THESE PRESENTS:

This Agreement is made and entered into this 13th day of JULY, 2021 at Tagum City, Davao del Norte, Philippines, between:

PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg., Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

BRGY. MANGALCAL WOMEN'S HOMEBASED WORKERS ASSOCIATION, registered worker's association under the Department of Labor and Employment with Registration No. ROXI - DNFO - WA-07-2016-078 and business address at Purok 3, Mangalcal, Carmen, Davao del Norte, duly represented by its Chairperson, **MELDRID REGILDA Q. DENOYO**, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity under **General Fund CY 2021**, intends to apply the sum of **FORTY-SEVEN THOUSAND NINE HUNDRED SEVENTEEN PESOS AND TWENTY CENTAVOS (PHP 47,917.20)** being the Approved Budget for the Contract (ABC) for the Contract - Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges - **11DAN079: Cebulano - Loceta**, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through **BAC Resolution No. 115, series of 2021**, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

and remedy any defects therein in conformity with the provisions of this contract in all respects;


