

## CONTRACT AGREEMENT

One (1) Package Consultancy Service for a Comprehensive Study of the River Carrying Capacity of the Libuganon River in Davao del Norte – Sand and Gravel Deposits

This Agreement is made and entered into this 09 day of FEB, 2022 at Tagum City, Davao del Norte, Philippines, between:

**PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE**, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg., Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

**-AND-**

**NAVI GEO-CONSTRUCTION CORPORATION**, a registered corporation under the Securities and Exchange Commission with Company Registration No. CS202060076, dated 17-January-2020, with business address at Casinabe Compound, Km. 17, Brgy. Ilamg, Davao City, duly represented by its authorized and designated representative, **ANNA MARIE M. ALMORIN**, hereinafter referred to as the **CONSULTANT**.

**WHEREAS**, the Procuring Entity through Mineral Resources Mgt. Project – Research, Exploration and Development Expenses – 50207020 intends to apply the sum of One Million Pesos Only (Php 1,000,000.00) being the Approved Budget for the Contract (ABC) for the **One (1) Package Consultancy Service for a Comprehensive Study of the River Carrying Capacity of the Libuganon River in Davao del Norte – Sand and Gravel Deposits** under **Purchase Request No. 2021090456** hereinafter called “the Works” and the Procuring Entity has accepted the bid for One Million Pesos Only (Php 1,000,000.00) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;



  - (j) Notice of Award of Contract and the Bidder's conforme thereto;

In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
