WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

WHEREAS, the Procuring Entity through 20% Development Fund CY 2023, intends to apply the sum of THREE HUNDRED FIVE THOUSAND EIGHT HUNDRED SIXTY-SEVEN PESOS AND FIFTY-THREE CENTAVOS (PHP305,867.53) being the Approved Budget for the Contract (ABC) for the Contract – Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining the Provincial Road in - FD. RD. 3 - KIMAMON – LUNA (REVISED) Add I, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 244, series of 2023, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **KATIPUNAN PANTARON IRRIGATORS ASSOCIATION (KAPANIA), INC.** with approved project pursuant to **PR No. 2023063672**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract – Community Based Road Maintenance Contracting (CBRMC) for the maintenance of Provincial Road in – FD. RD. 3 - KIMAMON – LUNA (REVISED) Add I.

Progress billing will be made within the quarter.

II-DURATION

The intended project should be done within **one hundred eighty-three (183)** calendar days from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of THREE HUNDRED FIVE THOUSAND EIGHT HUNDRED SIXTY-SEVEN PESOS AND FIFTY-THREE CENTAVOS (PHP305,867.53). The Contractor submitted a bid quotation of THREE HUNDRED FIVE THOUSAND EIGHT HUNDRED PESOS (PHP305,800.00).

 - 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the
