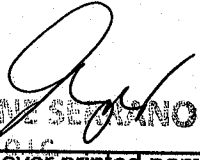
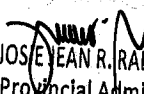

2. For staggered deliveries, the procuring entity shall make, after every delivery, an accounting of the amount actually payable based on the date of the delivery receipt to determine the allowable unit/volume that may still be ordered from the remaining amount allotted for each POL product. The procuring entity shall be allowed to make adjustments in the units/volume to be delivered per type of product to conform to the remaining amount in the total contract price.
3. The supplier shall be responsible to dispense fuel to **Office of 1st District BM PROSPERO E. ESTABILLO** vehicles only and ensure that issued fuel will not exceed PO allocation.

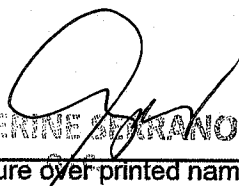
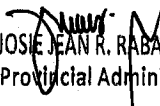
10. Additional fund allocation due to supplemental budget, augmentation shall follow the usual procedures of procurement.
