WHEREAS, the Procuring Entity through REPAIRS AND MAINTENANCE OF PROVINCIAL ROADS DIST. 2 — REPAIRS AND MAINT. — INFRASTRUCTURE ASSETS (50213030), intends to apply the sum of SIXTY-THREE THOUSAND ONE HUNDRED NINE PESOS AND NINETEEN CENTAVOS (PHP 63,109.19) being the Approved Budget for the Contract (ABC), COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 — MUGAS - LANATAD (REVISED) ADD I governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **KATIPUNAN PANTARON IRRIGATORS ASSOCIATION (KAPANIA), INC.** with approved project pursuant to **PR No. 2024042445**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of **COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 – MUGAS - LANATAD.**

Progress billing will be made within the quarter.

II-DURATION

The intended project should be done **within two (2) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of SIXTY-THREE THOUSAND ONE HUNDRED NINE PESOS AND NINETEEN CENTAVOS (PHP 63,109.19). The Contractor submitted a bid quotation of SIXTY-THREE THOUSAND ONE HUNDRED PESOS (PHP 63,100.00).

IV-GENERAL TERMS AND CONDITIONS

- 3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;
- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the same has been inspected and accepted by the community and confirmed by the
