WHEREAS, the Procuring Entity through REPAIRS AND MAINTENANCE OF PROVINCIAL ROADS DIST. 2 — REPAIRS AND MAINT. — INFRASTRUCTURE ASSETS (50213030), intends to apply the sum of EIGHTY-FIVE THOUSAND NINETY-ONE PESOS AND FIVE CENTAVOS (PHP 85,091.05) being the Approved Budget for the Contract (ABC), COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 — DUJALI — NEW CASAY (REVISED) ADD I governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

**NOW THEREFORE,** for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

#### **I-CONTRACT**

This agreement is an infrastructure project between the PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE and BRAULIO E. DUJALI, CASAY, IRRIGATORS ASSOCIATION (BEDUCASIA), INC. with approved project pursuant to PR No. 2024042455, hereinafter called the "Community-Based Road Maintenance Contract".

  - V. Legal, Technical and Financial Documents
- 3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;
- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the same has been inspected and accepted by the community and confirmed by the
