JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

**LUNGA-OG TRIBAL ASSOCIATION,** a registered workers' association under the Department of Labor and Employment Registration No. **ROXI – DNFO – WA – 03 – 2016 – 010** and business address at Brgy. Lunga-og, Sto. Tomas, Davao del Norte, duly represented by its Chairperson, **DATU EDGAR A. SABEJON**, by virtue of Board Resolution No. <u>2024-01</u>, hereinafter referred to as the **CONTRACTOR**.

#### **WITNESSETH THAT:**

**WHEREAS,** the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

**WHEREAS**, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 18-2021 dated October 22, 2021, it recognizes the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity through REPAIRS AND MAINTENANCE OF PROVINCIAL ROADS DIST. 2 — REPAIRS AND MAINT. — INFRASTRUCTURE ASSETS (50213030), intends to apply the sum of ONE HUNDRED TWENTY-SEVEN THOUSAND SIX HUNDRED THIRTY-SIX PESOS AND FIFTY-SEVEN CENTAVOS (PHP 127,636.57) being the Approved Budget for the Contract (ABC), COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 — PRK. APITONG — UPPER BALISONG — DALISAY (REVISED) ADD I governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 171, series of 2024, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

**WHEREAS**, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

#### **I-CONTRACT**

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **LUNGA-OG TRIBAL ASSOCIATION** with approved project pursuant to **PR No. 2024042443**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of **COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 - PRK. APITONG - UPPER BALISONG - DALISAY** (REVISED) ADD I.

Progress billing will be made within the quarter.

The intended project should be done **within two (2) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

### **III-CONTRACT PRICE**



- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contract of has
