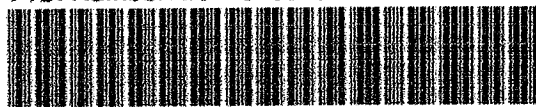



6. Payment shall be made by the **Office of the Secretary to the Sangunian** within **10** calendar day/s from receipt of the **15 days** billing with complete attachments covering actual purchases.

9. No advance withdrawal is allowed prior to the approval of the Purchase Order.


10. Additional fund allocation due to supplemental budget, augmentation shall follow the usual procedures of procurement.
